## AGREEMENT AND RELEASE OF LIABILITY (MINORS)

...am under twenty one (21) years and am freely and voluntarily visiting or volunteering at the Gibbon Conservation Center (“the GCC”).

I am informed and understand that the GCC cares for and houses wild animals upon its property that are unpredictable and dangerous. These animals may also harbor harmful diseases that can be transmitted to humans.

I am informed and understand that I place my person and property in danger by visiting the GCC.

Knowing these risks, I voluntarily accept them and agree to assume any and all risks of injury or death as a result of visiting or volunteering at the GCC.

In consideration of being permitted to enter the GCC’s property for any purpose, including, without limitation, observation, use of facilities or equipment, or participation in any way, Volunteer acknowledges, agrees, and represents that Volunteer has, or immediately upon entering will, inspect the GCC’s property, facilities, and equipment (collectively “GCC Property”).

It is further warranted that entry on the GCC Property for observation, participation, or use of any facilities or equipment constitutes an acknowledgment that the GCC Property was inspected and that Volunteer finds and accepts it as safe and reasonably suited for the purposes of observation or use.

The GCC will take all such steps and/or actions as in its sole discretion are appropriate and reasonable under the circumstances of such a wild animal refuge, to prevent injury and /or harm to any volunteer at the facilities and or while engaged in the activities of and on behalf of the facility and will take such steps in the case of a medical and/or injury-related emergency to get and/or obtain such care and /or medical treatment as may be reasonably necessary in its sole discretion under the circumstances.

Notwithstanding the above, in further consideration of being permitted to enter the GCC Property for any purpose, Volunteer agrees to the following:

		While Volunteer is on the GCC Property, Volunteer releases, waives, and discharges the GCC, its owners, agents, volunteers, or employees ("Releasees") from any liability to Volunteer for any loss or damage resulting from personal or property injury, including death, whether caused by Releasees' negligence or otherwise; Volunteer further covenants not to sue for any such liability.
		Volunteer agrees to indemnify and save and hold harmless Releasees from any loss, liability, damage, or cost Releasees may incur due to Volunteer's presence at the GCC Property or in any way observing or using any the GCC facilities or equipment, whether caused by Releasees' negligence or otherwise.
		Volunteer further expressly agrees that the foregoing release, waiver, and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of the State of California and that if any portion is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

By initialing and/or signing these provisions and agreement, we indicate that we have carefully read and fully understand its contents. We are aware that this is a release of liability and a contract between myself/my minor child. We sign this document of our own free will and we have had the opportunity to ask questions concerning the meaning of the document, its provisions and the dangers involved in visiting or volunteering for the GCC, and any such questions we may have had, have been answered to our satisfaction.
